(NYSE:TOL), the nation's leading builder of luxury homes, will broadcast live on its website, www.tollbrothers.com, a conference call to discuss its preliminary results and outlook for fourth quarter 2005. The event is scheduled for 2:00 p.m. (EST) on Tuesday, November 8, 2005. It will follow announcement of the Company's fourth quarter and full fiscal year 2005 preliminary results for home building revenues, contracts and backlog before the market opens on Tuesday, November 8, 2005. The call will be hosted by Robert I. Toll, Chairman and Chief Executive Officer.

Toll Brothers builds luxury single-family detached and attached home communities, master planned luxury residential resort-style golf communities and urban low-, mid- and high-rise communities, principally on land it develops and improves. The Company operates its own architectural, engineering, mortgage, title, land development and land sale, golf course development and management, home security, landscape, cable TV and broadband Internet delivery subsidiaries. The Company also operates its own lumber distribution, and house component assembly and manufacturing operations.
